

**2012 CAMTOWN YOUTH FESTIVAL
KIDS' FLEA MARKET VENDOR BOOTH REGULATIONS
JUNE 9, 2012; CROWN PARK; CAMAS, WA**

PROVISIONS: All vendors will supply their own tent, table, chairs, table covering, signage, etc. A 10'x10' space will be provided to you as arranged through your registration.

CHECK-IN AND SPACE LOCATIONS: Check-in is required before setting up your booth area. Check in at the canopy tent positioned on the south side of the swimming pool – see attached site map for specific location. Staff will be stationed there to help direct you to your vendor site and to assist with any parking issues. **Vehicles will not be allowed access into the park for unloading.** Do not double-park in the street.

SET-UP TIMES & RUN TIME: Vendors must be set up and ready to go by 10:45AM. Access to the park will be available beginning at 9:00AM. Vendor spaces must stay open to the public until 3:00pm; do not close early as the festival does receive late arrivals.

DOGS NOT ALLOWED: Crown Park is the only park in Camas that does not allow dogs. All other City parks allow dogs on leash.

NO ENTERTAINMENT OR PERFORMANCE-STYLE DEMONSTRATIONS WILL BE ALLOWED. This includes singing, dancing, cheer, martial arts, etc. If you wish to share a demonstration with or entertain our crowd, please contact Krista Bashaw at 834-5307 to be scheduled at one of the entertainment areas.

NO BACKGROUND MUSIC: Background music (i.e. from a cd player, boom box, etc.) will not be allowed so as not to compete with the scheduled festival entertainment. Listening to music with headphones is OK.

NO SMOKING; NO ALCOHOL. This is a youth-oriented festival. Need we say more?

NO VEHICLES ALLOWED IN THE PARK – bring a dolly, wagon, cart or other delivery device to load your items into and out of the park.

NO POWER WILL BE AVAILABLE TO VENDORS. Due to limited electrical availability vendors will not be allowed to hook up to power. Please plan a display that does not require the use of electricity or power. Due to noise issues, generators will not be allowed.

DESCRIPTION OF ITEMS YOU PLAN TO SELL MUST BE LISTED BELOW FOR PRE-APPROVAL:

Commercial-type items are not allowed for sale; food items not allowed; flea market items must be hand-crafted, home-made, or kid-related garage sale type items. Adults are not allowed to sell at the booth; youth sellers only; adults must be present for supervision.
