This section of NE Franklin services a number of people who are low/mod income and is eligible for CDBG participation. The project was completed in September 2016.
- On May 28, 2015, the City of Camas invited the public and project stakeholders to an Open House to learn about the City's plans to construct S-584 NW 6th and Norwood Intersection Improvements project. The project will construct a roundabout and provide for pedestrian access improvements.
 - O The WSDOT brochure entitled *Your Rights under Title VI and Related Statutes* was distributed.
 - O Placed on the registration table were copies of the Title VI Public Involvement form (WSDOT Form 272-059 EF), a "ballot" box, and tent card with the following statement: "We ask that you voluntarily complete the Title VI Public Involvement form and place it in this box. You are not

- required to disclose the information requested in order to participate in this meeting."
- O During the presentation, property owners in the affected area were asked to complete the Title VI Public Involvement form. There were approximately forty attendees, including twenty-eight members of the public, consultants, city staff, and one WSDOT representative. Three Title VI Public Involvement forms were completed.
- The project is under construction with an anticipated completion date of February 2017.
- A Public Hearing was held on November 16, 2015, to allow public input in consideration of a CDBG application submittal for the rehabilitation of NE Franklin Street from 19th Avenue to 22nd Avenue. The funding application was submitted on December 1, 2015. The project is described below:
 - S-607 NE Franklin Neighborhood North Improvements will provide for various water, sewer, street, and sidewalk improvements on NE Franklin Street between NE 19th and NE 22nd Avenue. This section of NE Franklin services a number of people who are low/mod income and is eligible for CDBG participation. The expected project completion date is February 2017.
- A Public Hearing was held on November 21, 2016, to allow public input in consideration of a CDBG application for the rehabilitation of NE Dallas Street from 17th to 21st Avenue. The application was submitted on November 23, 2016. If funds are awarded, the project will provide the following:
 - T1008 NE Dallas Street Improvements will provide for various water, sewer, street, and sidewalk improvements on NE Dallas Street between NE 17th and NE 21st Avenue. This section of NE Dallas services a number of people who are low/mod income and is eligible for CDBG participation.

 - There were no Environmental Justice related impacts during the reporting period of January 1, 2016, through December 31, 2016.

 - Camas Mobility (ADA) Improvement projects: These projects are coordinated in several ways. They are consistent with the Camas Comprehensive Plan Policies and Strategies that encourage installation of pedestrian facilities. They conform to the Camas Municipal Code section that deals with street design. Staff works

- closely with the Camas and Washougal School Districts to ensure that improvements are made to permit students a safe route to school. The projects fit with City strategies to re-invest in our older modest neighborhoods and continuing efforts to tie neighborhoods to public facilities such as essential services, downtown, schools, parks, and greenways.
- S-584 NW 6th and NW Norwood Intersection Improvements: Initially, the City had planned to design a traffic signal at this intersection. Through the design and traffic analysis process the option of a roundabout was suggested by representatives from WSDOT. City Staff discussed this suggestion further with Mayor and City Council during multiple meetings, consultant presentations, and the May 2015 Open House. Staff was directed by Council to move forward on design of a roundabout. The project will reconstruct the NW 6th Avenue and NW Norwood Street Intersection (including a portion of the SR-14 on/off ramps) to construct a roundabout and provide for improved pedestrian access. The anticipated completion date is February 2017.
- S-584B NW 6th Avenue Pedestrian Crossing Upgrades:
 - Upgrades were completed to the crossing at NW 6th Avenue and NW Ivy Street in December 2015.
 - o In-house design of the NW 6th Avenue and NW Drake Street Pedestrian Crossing Upgrades project was performed in 2016. Construction is expected to commence in 2017.
- S-587 NW Brady Road Improvements: In December 2014, Camas awarded a professional services contract to design improvements to NW Brady Road from NW 16th Avenue to NW 25th Avenue with three lanes, bike lanes, sidewalks, storm system, illumination, and utilities. This project is currently under design.

- P-890 Cooper's View Park: construction of a new park including ADA compliant concrete and asphalt pathways, concrete seat wall with concrete terrace, play area with play structures, site furnishings, landscaping and irrigation, stormwater collection system, erosion control, and other related work. Street parking is available with curb ramps for ADA access. This project was completed in November 2016.
- S-607 NE Franklin Neighborhood North Improvements will provide for various water, sewer, street, and sidewalk improvements on NE Franklin Street between NE 19th Avenue and NE 22nd Avenue. This section of NE Franklin services a number of people who are low/mod income and is eligible for CDBG participation. The expected project completion date is February 2017.
- Street Illumination Upgrades. As stated in the WSDOT Design Manual (Chapter 1040 Illumination): Illumination is provided along highways, in parking lots, and at other facilities to enhance the visual perception of conditions or features that require additional motorist, cyclist, or pedestrian alertness during the hours of darkness.
 - S-580 LED Street Lighting Upgrades citywide project to replace over 3,000 street light fixtures or retrofit, when applicable, including all necessary ancillary equipment. The project was completed in August 2016.
 - S-610 Pacific Rim Boulevard Illumination provides for the improvement of roadway illumination along NW Pacific Rim Boulevard between SE Payne Road and NW Parker Street. This project was designed in 2016 and bid in January 2017. Construction will be completed in 2017.

- As funding becomes available, the City of Camas constructs improvements to the Camas Parks and Open Space system to offer ADA compliant access to facilities, apparatus, parking, and linkages to the trail system. As stated in the City of Camas Parks, Recreation, and Open Space Comprehensive Plan, PROS GOAL 2: Provide active and passive recreation opportunities to serve the community's needs.
- City Staff works in conjunction with the Downtown Camas Association to address parking, sidewalk, and access issues within the downtown business core.
- City Staff works in conjunction with the Camas and Washougal School Districts to provide safe routes to our schools.
- City Staff Training:
 - City employees attend training sessions that enable staff to design and construct ADA accessible sidewalks and trails for public access.
 - Staff monitors and takes full advantage of WSDOT training programs (e.g., Title VI training, Title VI Coordinator's meetings, transportation, ADA, pedestrian accommodations, inspection, construction documentation, ROW training, Local Agency ROW meetings, Every Day Counts (EDC) webinars, etc.).
 - On February 18, 2016, staff participated in the Transportation Efficient Communities webinar.
 - o On February 24, 2016, staff attended the Local Agency ROW Meeting.
 - On March 2, 2016, staff attended the DBE Program Training for Public Agency workshop.
 - On March 22, 2016, staff participated in the webinar entitled No Right of Way Verification.
 - On November 1, 2016, staff attended Work Zone Control Plan Development training.
- Per Camas Municipal Code Land Division Title 17:
 - o 17.19.020.A.1: Every developer shall be required to grade and pave streets and alleys, install curbs and gutters, sidewalks, monuments, sanitary and storm sewers, water mains, fire hydrants, street lights and street name signs, underground transmission lines, provide and install centralized mail delivery boxes as determined by the U.S. Postal Service, together with all appurtenances in accordance with specifications and standards in the Camas Design Standard Manual, the six-year street plan, and other state and local adopted standards and plans as may be applicable.
 - 17.19.040.B.1: Half Width Improvement. Half width improvements, when determined appropriate by the City Engineer, shall include utility easements, pedestrian pathway, storm water drainage, street lighting and signage, environmental permits, provisions for mitigation improvements and mitigation areas as necessary, bike lanes, and improvements to the centerline of the right of way as necessary to provide the minimum structural street section per the Camas Design Standard Manual.

- When developing bid specifications and contracts for construction projects, the City of Camas incorporates the WSDOT Standard Specifications for Road, Bridge and Municipal Construction manual into the documents, which includes section 1-07.11 Requirements for Nondiscrimination.
- As funding permits, City Staff addresses the need for curb ramps to provide ADA accessible sidewalks. Camas staff maintains a *Sidewalk Request Log* (electronic path) to document requests and inquiries.
- On October 11, 2016, City staff received an inquiry on the lack of a handicapped curb access point on the southwest corner of NE Birch Street and NE 3rd Avenue. A draft design has been developed and added to our Sidewalk Request Log. This request will be re-evaluated as funding permits.
- The City of Camas is compliant with the CDBG Fair Housing information requirement. Staff has placed information entitled *Fair Housing, Your Rights and Responsibilities* on our website and have provided a link to the Clark County Department of Community Services, Fair Housing web page.
- The City of Camas has developed an Interpreter / Translation Services Information Packet. The packet has been distributed to all City departments. The packet provides contact information and guidance in requesting language services (e.g., Limited English Proficiency, American Sign Language, and assistance for Deaf, Deaf-Blind, Blind, or Hard of Hearing individuals). I Speak Cards are included in the packet.

6. If Right of Way has been acquired for a transportation project, please describe:

- S-584 NW 6th and NW Norwood Intersection Improvements: Initially, the City had planned to design a traffic signal at this intersection. Through the design and traffic analysis process the option of a roundabout was suggested by representatives from WSDOT. This project is funded by the City of Camas. Right of way from one adjacent property owner is required. The City has negotiated the purchase of 1,434 square feet of land.
