- a. Describe any required Title VI activities and/or studies conducted that provided data relative to minority persons, neighborhoods, income levels, physical environment, and travel habits.
 - NW Brady Road Improvements: In December 2014, Camas awarded a
 professional services contract to design improvements to NW Brady Road from
 NW 16th Avenue to NW 25th Avenue with three lanes, bike lanes, sidewalks,
 storm system, illumination, and utilities. This project is partially funded by an
 FHWA STP grant. Activity in 2017 included surveying, environmental

2016 Estimate (U.S. Census)

- permitting, traffic analysis, and right-of way. These activities will continue into 2018 with completion of the National Environmental Policy Act (NEPA) including the Environmental Justice (EJ) component expected by early-Spring using statistical data from multiple sources. Construction is anticipated in 2019/2020.
- A Public Hearing was held on November 21, 2016, to allow public input in consideration of a Community Development Block Grant (CDBG) application for the rehabilitation of NE Dallas Street from 17th to 21st Avenue in the CDBG eligible tract C.T. #414, B.G. #1. The funding application was submitted in November 2016. The City's application was successful. A review of the Statistical Atlas website (Attachment 1) provides race and ethnicity, age, and income information to help City staff determine impacts to this neighborhood. The project will construct the following:
 - NE Dallas Street Improvements will provide for various sidewalk, street, water, and sewer improvements on NE Dallas Street between NE 17th and NE 21st Avenue. This section of NE Dallas services a number of people who are low/mod income and is eligible for CDBG participation.
 - 2017 activities included: preliminary engineering, environmental, traffic study, and design. Construction will occur in 2018.
- NW Camas Meadows/Larkspur Street Improvements project. This road widening project will include left turn lanes, bike lanes, sidewalks, median, utilities, illumination and signal modifications. This project is partially funded with a Transportation Improvement Board Fuel Tax Grant. A review of the Statistical Atlas website (Attachment 2) provides race and ethnicity, age, and income information to help City staff determine impacts to this neighborhood.
 - 2017 activities include: preliminary engineering, environmental, permits traffic analysis, design, and right-of-way. The improvements to NW Larkspur Street will increase the capacity of the street to accommodate the anticipated increase in traffic from new developments to the north. The improvements will increase traffic safety and provide for pedestrian and bicycle travel through the corridor.
 - o Construction is anticipated in 2018.
 - The City has conducted multiple outreach activities including a mass mailer; communications in-person, verbal, and written to citizens directly impacted by the roadway improvements; postings on the City of Camas website, as well as, an Open House. The Statistical Atlas shows there may be Asian speaking persons along the Larkspur corridor. To-date, there have been no requests for interpretive/translation services or other accommodations.
 - On July 11, 2017, the City of Camas invited the public and project stakeholders to an Open House to learn about the City's plans to construct this project:
 - The WSDOT brochure entitled *Your Rights under Title VI and Related Statutes* was distributed.
 - Placed on the registration table were copies of the Title VI Public Involvement form (WSDOT Form 272-059 EF), a "ballot" box,

- and tent card with the following statement: "We ask that you voluntarily complete the Title VI Public Involvement form and place it in this box. You are not required to disclose the information requested in order to participate in this meeting."
- During the presentation, property owners in the affected area were asked to complete the Title VI Public Involvement form. There were approximately thirty-five attendees, including members of the public, Camas City Council, consultants, and city staff. One Title VI Public Involvement form was completed.
- The Forest Home Road Slide Repair project was partially funded by an FHWA ER grant. The project includes excavation of slide material, construction of a gabion wall, structural backfill, paving with HMA, installation of guardrail, and other related items. Preliminary engineering, design, and right of way began in March 2016. The NEPA was completed in August 2016, the project was deemed an Emergency Repair and was exempt from EJ. The City provided information on this project and road closure through news articles, a mass mailer, and multiple communications with property owners and others impacted by the slide. There were no requests for interpretive/translation services or other accommodations. The project was awarded in May 2017 and construction was completed by late-2017.
- o The Lacamas Lane Slide Repair project was partially funded by a FEMA grant. The project included removal of slide material debris, rock embankment (buttress), underdrain system to the public storm drainage system, street trees and erosion control plantings, sidewalk, asphalt pavement (storm trenching), streetlight, traffic control, and any other related items. Preliminary engineering and design began in April 2016. The City communicated multiple times with property owners and others impacted by the slide, including a mass mailer informing citizens of the construction and road closure schedule. There were no requests for interpretive/translation services or other accommodations. The project was awarded in March 2017 and construction was completed by Fall 2017.
- O A Public Hearing was held on November 6, 2017, to allow public input in consideration of a CDBG application for the rehabilitation of NE Adams Street from 19th to 21st Avenue in the CDBG eligible tract C.T. #414, B.G. #1. The funding application was submitted in November 2017. If funded, the project will provide for various sidewalk, street, water, and sewer improvements. This section of NE Adams services a number of people who are low/mod income and is eligible for CDBG participation. A review of the Statistical Atlas website (Attachment 1) provides race and ethnicity, age, and income information to help City staff determine impacts to this neighborhood.

 - The City will use data from multiple sources to determine impacts on Camas citizens including environmental justice, access, transportation, noise, economic and social effects, etc.
 - The City provides oversite to review all submissions from professional service firms to ensure there is no disproportionate impact on low-income, minority or other disadvantaged populations.
 - Public hearings are held and communication efforts are made to ensure citizen participation.

the project notice to the OMWBE for placement on their website. Staff also advertises in the C-W Post-Record and the Portland Daily Journal of Commerce.

- All Call for Bids and Requests for Proposals, initiated by the Camas
 Engineering Division of the Public Works Department, include the
 following paragraphs (unless specific language is required by our funding
 source):
 - As provided by Title VI of the Civil Rights Act of 1964, and the Civil Rights Restoration Act of 1987, the contractor, with regard to the work performed by it during the contract, shall not discriminate on the grounds of race, color, religion, sex or national origin in the selection and retention of sub-contractors, including procurement of materials and leases of equipment.
 - The City of Camas encourages the solicitation and recruitment, to the extent possible, of certified minority-owned (MBE), womenowned (WBE), emerging small (ESB) businesses, and other disadvantaged firms in construction of this project. The City of Camas is an Equal Opportunity Employer.
- The City provides project plans and specifications to multiple plan centers for all advertised projects. Camas staff realizes that Plan Centers provide a valuable service to the contracting community, primarily subcontractors.
- Transportation related Public Hearing Notices include language with regard to Title VI.
- The City of Camas' website provides Title VI assurances and offers contact information to request language or special needs assistance. The telephone number posted is not an auto-attendant line and is answered by an administration employee during regular business hours.
- The City has developed an Interpreter / Translation Services Information Packet. The packet has been distributed to all City departments. The packet provides contact information and guidance in requesting language services (e.g., Limited English Proficiency, American Sign Language, and assistance for Deaf, Deaf-Blind, Blind, or Hard of Hearing individuals). I Speak Cards are included in the packet.
- Public Hearing Notices are published in the C-W Post-Record and posted at the Camas Municipal Center, Camas Public Library, and on the City of Camas website. The following Public Hearings and decisions impacting transportation related activities were conducted by City Council at Regular Meetings in 2017:
 - The City Council Annual Planning Conference was held over two-days on January 27 and January 28, 2017. The agenda included goal setting and discussions on a variety of subjects affecting our community.
 - A Public Hearing was held on May 1, 2017, to review a request from Electric Lightwave (ELI), LLC, that the City grant it the right to install, operate, and maintain a fiber optic-based telecommunications system within the public right-of-way. On May 15, 2017, City Council adopted Ordinance No. 17-006 granting ELI a non-exclusive franchise for the transmission of telecommunications.

- A Public Hearing was held on June 5, 2017, to allow public input regarding revisions to the City of Camas Six Year Transportation Improvement Program (STIP). City Council adopted the resolution to revise and extend the STIP on June 19, 2017.
- On June 19, 2017, Mayor was authorized by City Council to sign an Interlocal Agreement with Clark County regarding roadway improvement projects for the Camas School District (CSD) adjacent to the City limits, but located in Clark County. The CSD is developing three parcels on roads within the Camas Urban Growth Boundary and the City has intent to annex these roadways. The agreement will allow right-of-way and roadway improvement projects to be processed through the City.
- o On July 17, 2017, City Council unanimously approved the 2018-2020 City of Camas Strategic Plan to assist in prioritizing work over the next three years and beyond. Major components of the plan include: Our Vision, Decision Principals, Internal Values, Strategic Priorities, Key Objectives, and Key Initiatives. The Strategic Plan will guide the City's decision making process on meeting the Community's needs, financial stability, infrastructure, and manage growth in line with our vision.
- A State of the Community event was held on October 26, 2017. The
 meeting featured presentations by the City of Camas and Camas School
 District. Citizens heard about accomplishments and challenges in the last
 year and what is on the horizon.
- O A Public Hearing was held on November 6, 2017, to allow public input in consideration of a Community Development block Grant application for the rehabilitation of NE Adams Street from 19th to 21st. City Council authorized submission of the application.

 - There were no Environmental Justice related impacts during the reporting period of January 1, 2017, through December 31, 2017.

 - Camas Mobility (ADA) Improvement projects: These projects are coordinated in several ways. They are consistent with the Camas Comprehensive Plan Policies and Strategies that encourage installation of pedestrian facilities. They conform to the Camas Municipal Code section that deals with street design. Staff works closely with the Camas and Washougal School Districts to ensure that improvements are made to permit students a safe route to school. The projects fit with City strategies to re-invest in our older modest neighborhoods and continuing efforts to tie neighborhoods to public facilities such as essential services, downtown, schools, parks, and greenways.
 - S-584B NW 6th Avenue Pedestrian Crossing Upgrades:

- o In-house design of the NW 6th Avenue and NW Drake Street Pedestrian Crossing Upgrades project was performed in 2017. Construction will be completed in-2018.
- S-587 NW Brady Road Improvements: In December 2014, Camas awarded a professional services contract to design improvements to NW Brady Road from NW 16th Avenue to NW 25th Avenue with three lanes, bike lanes, sidewalks, storm system, illumination, and utilities. This project is currently under design.
- S-610 Pacific Rim Boulevard Illumination provides for the improvement of roadway illumination along NW Pacific Rim Boulevard between SE Payne Road and NW Parker Street. This project was designed in 2016 and bid in January 2017. Construction will be completed in January 2018.
- As funding becomes available, the City of Camas constructs improvements to the Camas Parks and Open Space system to offer ADA compliant access to facilities, apparatus, parking, and linkages to the trail system. As stated in the City of Camas Parks, Recreation, and Open Space Comprehensive Plan, PROS GOAL 2: Provide active and passive recreation opportunities to serve the community's needs.
- City Staff works in conjunction with the Downtown Camas Association to address parking, sidewalk, and access issues within the downtown business core.
- City Staff works in conjunction with the Camas and Washougal School Districts to provide safe routes to our schools.
- City Staff Training:
 - City employees attend training sessions that enable staff to design and construct ADA accessible sidewalks and trails for public access.
 - Staff monitors and takes full advantage of WSDOT training programs (e.g., Title VI training, Title VI Coordinator's meetings, transportation, ADA, pedestrian accommodations, inspection, construction documentation, ROW training, Local Agency ROW meetings, Every Day Counts (EDC) webinars, etc.).
 - o On February 22, 2017, staff attended the Local Agency ROW Meeting.
 - On March 16, 2017, staff participated in the webinar entitled No Right of Way Verification.
 - o On September 12, 2017, staff participated in the B2GNow Prompt Pay by Prime Contractor workshop.
- Per Camas Municipal Code Land Division Title 17:
 - 17.19.020.A.1: Every developer shall be required to grade and pave streets and alleys, install curbs and gutters, sidewalks, monuments, sanitary and storm sewers, water mains, fire hydrants, street lights and street name signs, underground transmission lines, provide and install centralized mail delivery boxes as determined by the U.S. Postal Service, together with all appurtenances in accordance with specifications and standards in the Camas Design Standard Manual, the six-year street plan, and other state and local adopted standards and plans as may be applicable.

- O 17.19.040.B.1: Half Width Improvement. Half width improvements, when determined appropriate by the City Engineer, shall include utility easements, pedestrian pathway, storm water drainage, street lighting and signage, environmental permits, provisions for mitigation improvements and mitigation areas as necessary, bike lanes, and improvements to the centerline of the right of way as necessary to provide the minimum structural street section per the Camas Design Standard Manual.
- When developing bid specifications and contracts for construction projects, the City of Camas incorporates the WSDOT Standard Specifications for Road, Bridge and Municipal Construction manual into the documents, which includes section 1-07.11 Requirements for Nondiscrimination.
- As funding permits, City Staff addresses the need for curb ramps to provide ADA
 accessible sidewalks. Camas staff maintains a Sidewalk Request Log (electronic
 path) to document requests and inquiries.
- City staff received an inquiry on the lack of a handicapped curb access point on the southwest corner of NE Birch Street and NE 3rd Avenue. This work has been included in the ADA Improvements for Surface Treatment Projects (Attachment 3).
- In February 2017, the City installed two ADA ramps on SE 7th Avenue in conjunction with a sidewalk improvements project.
- City staff has developed a mechanism to track small scale contracts and agreements. In 2017, the following transportation related safety repairs occurred: NE 3rd Ave. Bridge railing (addition work scheduled in 2018), curb railing repairs on Woodburn drive, street light repairs, and guardrail repairs.
- The City of Camas is compliant with the CDBG Fair Housing information requirement. Staff has placed information entitled *Fair Housing, Your Rights and Responsibilities* on our website and have provided a link to the Clark County Department of Community Services, Fair Housing web page.
- The City of Camas has developed an Interpreter / Translation Services
 Information Packet. The packet has been distributed to all City departments. The
 packet provides contact information and guidance in requesting language services
 (e.g., Limited English Proficiency, American Sign Language, and assistance for
 Deaf, Deaf-Blind, Blind, or Hard of Hearing individuals). I Speak Cards are
 included in the packet.

6. If Right of Way has been acquired for a transportation project, please describe:

- NW Payne Street Acquisition. In cooperation with property owners, two Deed of Dedication documents were executed and recorded for public right-of way purposes for the purpose of constructing, improving, and maintaining NW Payne Street.
- Forest Home Road Slide Repair. The slope to the south of Forest Home Road failed due to erosion at the toe of the slope from the adjacent creek and water from the roadway, following an extreme rain event in December 2015. The resulting failure undermined the roadway resulting in a full road closure. The City acquired the right-of-way necessary to facilitate the project from two property owners.












Map of Race and Ethnicity by Block in Block Group 041400-1



Map of Race and Ethnicity by Block in Block Group 041400-1










Map of Race and Ethnicity by Block in Block Group 040608-1




