

ORDINANCE NO. 1995

AN ORDINANCE appropriating \$15,000.00 for professional services for preliminary building need studies for the Police and Fire Departments, and amending the Budget of the City of Camas for the year 1994 to provide for such expenditure.

WHEREAS, the Council desires to undertake preliminary building studies for the Police and Fire Departments, and

WHEREAS, the estimated cost of such studies is \$15,000.00, and

WHEREAS, such expense was not budgeted in the 1994 Budget, and

WHEREAS, there are sufficient unappropriated funds in the General Fund to pay for such expenditure, now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$15,000.00 is hereby appropriated from unappropriated funds in the General Fund to pay for preliminary building studies for the Police and Fire Departments, and is allocated as follows:
