

ORDINANCE NO. 2000

AN ORDINANCE amending Section 13.36.010 of the Camas Municipal Code by revising the rates for water service.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

Section 13.36.010 of the Camas Municipal Code is amended to provide as follows:
