

ORDINANCE NO. 2003

AN ORDINANCE appropriating \$4,200.00 from the Sanitary Fund for the purchase of 200 recycling bins, and amending the Budget of the City of Camas for the year 1994 to provide for such expenditure.

WHEREAS, the Public Works Department has determined that it is necessary to purchase an additional 200 recycling bins for the residential recycling program, and

WHEREAS, the estimated cost of such bins is \$4,200.00; and

WHEREAS, such expense was not budgeted in the 1994 Budget, and

WHEREAS, there are sufficient unappropriated funds in the Sanitary Fund to pay for such expenditure, now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$4,200.00 is hereby appropriated from unappropriated funds in the Sanitary Fund to pay for the purchase of 200 additional recycling bins, and is allocated as follows:
