

ORDINANCE NO. 2191

AN ORDINANCE adopting a new master program entitled "Camas Shoreline Master Program, December 14, 1998" as the master program for regulation of the shorelines within the City of Camas, and repealing Ordinance No. 2156.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

The Council makes the following findings:

- A. The City of Camas has heretofore adopted a document entitled "Shoreline Management Master Program, October 24, 1977" as the master program for regulation of the shorelines within the city as required by Chapter 90.58, Revised Code of Washington.
- B. Under Chapter 90.58, Revised Code of Washington, the City has a continuing obligation to provide specific criteria for the management of shorelines within the City of Camas.
- C. Since adoption of the initial Shoreline Management Master Program, the City has annexed territory which contains shorelines subject to regulation under RCW 90.58.
- D. The City of Camas formed a Citizens Advisory Committee to update the Shoreline Management Master Program by incorporating new shorelines of annexed territories into the master plan, and by updating and revising the substantive provisions in the plan.
- E. The Citizens Advisory Committee working in conjunction with the city planning staff have created a new document entitled "Camas Shoreline Master Program, December 14, 1998".
- F. The City has held public hearings before the Planning Commission and before the City Council to consider the Camas Shoreline Master Program, December 14, 1998 and to allow public comment.
- G. The Camas Shoreline Master Program, December 14, 1998 has been forwarded to the Department of Ecology for review and comment.
- H. During the Department of Ecology's thirty-day comment period, the City received correspondence regarding the master program.
- I. The city council has modified the Master Shoreline Program to include an aquaculture use with corresponding regulatory provisions. This modification was in response to comments received during the comment period.

J. The Department of Ecology has transmitted a letter dated December 30, 1998, approving the Camas Shoreline Master Program as modified.

K. The City desires to adopt the Camas Shoreline Master Program, December 14, 1998 as the master program for the regulation of the shorelines within the City of Camas.

Section II

That document entitled "Camas Shoreline Master Program, December 14, 1998" be and the same is hereby adopted as the master program of the City of Camas for the regulation of shorelines within the city.

Section III

Upon the effective date of this ordinance, that document entitled "Shoreline Management Master Program, October 24, 1997" shall be deemed superseded and shall have no further effect for any development, substantial development, conditional use, or variance under application under the Shorelines Management Act made after the effective date of this ordinance.


Section IV


Ordinance No. 2156 is repealed.


Section V
