

RESOLUTION NO. 922

A RESOLUTION establishing rental rates to be charged by the Equipment Rental Department of the City of Camas.

WHEREAS, the Council of the City of Camas created an Equipment Rental Department by Ordinance 1029; and

WHEREAS, said Ordinance provided that the Council should adopt a Resolution establishing rates charged for the rental of equipment administered by said department;

That the following listed rates shall be the charge for the rental of equipment administered by the Equipment Rental Department:




