NOW, THEREFORE, BE IT RESOLVED, that the City of Camas requests approval by the Department of Retirement Systems, Deferred Compensation Program to participate in the aforementioned deferred compensation plan for the employees of the city, subject to the requirements of RCW 41.50.770 and WAC Chapter 415-501.
