

RESOLUTION NO. 661

A RESOLUTION establishing speed limits on streets located in the area annexed to the City of Camas by Ordinance 1747

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The Council of the City of Camas finds upon the basis of an engineering and traffic investigation that the speed permitted by state law upon certain streets annexed to the City of Camas by Ordinance 1747 is less than is necessary for safe operation of vehicles thereon.

Section II

It is hereby declared that the speed limit for the following described streets or portions thereof be as hereinafter set forth at the time specified when signs are erected giving notice thereof, but in no case shall the speed limit exceed 40 miles per hour, except upon limited access highways or designated approaches thereto:

NW Brady Road from intersection of NW McIntosh Road north to NW Parker Street	35 mph	At All Times
NW Parker Street from NW Brady Road north to NW 38th Avenue	35 mph	At All Times
NW Hood Street from NW 16th Avenue north to NW 18th Avenue	35 mph	At All Times
NW Cascade Street from NW 18th Avenue north to NW 23rd Avenue	35 mph	At All Times
NW Astor Street from NW 11th Avenue north to NW 23rd Avenue	35 mph	At All Times
NW Astor Street from NW 38th Avenue north to NW 43rd Avenue	30 mph	At All Times
NW Sierra Street from NW 43rd Avenue north to NW 46th Avenue	30 mph	At All Times
NW McIntosh Road from intersection of NW Brady Road east to NW 11th Avenue	35 mph	At All Times
NW 11th Avenue from NW McIntosh Road east to NW Astor Street	35 mph	At All Times
NW 16th Avenue from intersection of NW Brady Road east to NW Hood Street	35 mph	At All Times

NW 18th Avenue from NW Hood Street east to intersection of NW Astor Street	35 mph	At All times
NW Forest Home Road from intersection of NW Astor Street southeast to a point 1,200 feet northwest of NW 10th Avenue	35 mph	At All Times
NW 23rd Avenue from NW Cascade Street east to NW Sierra Street	35 mph	At All Times
NW 38th Avenue from west City Limits east to NW Astor Street	40 mph	At All Times
NW 43rd Avenue from NW Astor Street east to NW Sierra Street	30 mph	At All Times
NW 46th Avenue from NW Sierra Street southeast to NW Lake Road	30 mph	At All Times
NW/NE Lake Road from west City Limits southeast to NW Everett Street (SR-500)	35 mph	At All Times
