Permission to use a particular facility may be denied based on a belief that the activity proposed may not be in the Camas Pool's best interests, or due to the level of previously scheduled use. No person shall be denied full enjoyment of the facilities because of race, creed, color, sex, or origin.

AGREEMENT AND INSURANCE

The person or organization entering into a rental agreement with the Camas Pool for the use of the pool facility or equipment described above certifies that the information given in this application is current. The undersigned further states that he/she has the authority to make this application for the applicant, and agrees that the applicant will observe all rules and regulations. The applicant further agrees to reimburse the Camas Pool for any damages arising from the applicant's use of said facilities. Any accident involving injury to participants or damages to facilities or equipment occurring during the use of the Camas Pool facilities or equipment will be reported to the Camas Pool staff immediately.

The applicant agrees that the Camas Pool and its agents or employees will not be liable for any damage to person or property by reason of negligent acts of the applicant, its agents, employees, invitees, or subcontractors. Applicant agrees to protect, indemnify for legal costs and other expenses, and hold harmless, the Camas Pool and its officers, employees, directors, and agents from claims, liabilities, or suits, arising out of injury to person or property from negligent acts of applicant, directly or indirectly attributable to user's activities and/or use of premises except for sole negligence of the Camas Pool.

Rules and Regulations

- Applicant/organization is responsible for the safety and conduct of its participants and spectators.
 - Satisfactory adult supervision must be provided by the applicant.
 - All events will be required to meet the occupancy load and fire regulations of the Camas Pool and the State of Washington.
 - Use of alcohol, tobacco, and/or drugs is prohibited. Profane language and/or other objectionable conduct may result in barred use of the facility.
 - Firearms and/or other dangerous weapons are prohibited on Camas Pool grounds as defined by law.
 - Access to facilities and services, except as otherwise addressed in these rules, shall be limited to that specified on the application.
 - Alterations to the facility are prohibited without prior approval. This may include things such as hanging signs, moving equipment, etc.
 - Camas Pool owned equipment shall not be removed from the facility or loaned to any individual or organization unless prior approval by the Camas Pool had been granted.
 - The applicant/organization will follow additional written and verbal rules given by the Camas Pool.
 - The applicant/organization shall not practice discrimination of any kind.
 - Cancellations by applicants require at least 24-hour notice. Other wise rental costs shall be borne by the applicant.
 - Facility use is cancelled when facility/building is closed due to an emergency.
 - The Camas Pool reserves the right to refuse or revoke any authorization used for the use of a Camas Pool building or grounds, and if rental has been paid, to refund such rental, less expenses incurred, by the Camas Pool in connection therewith.
